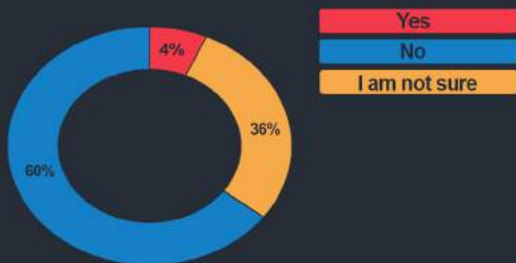

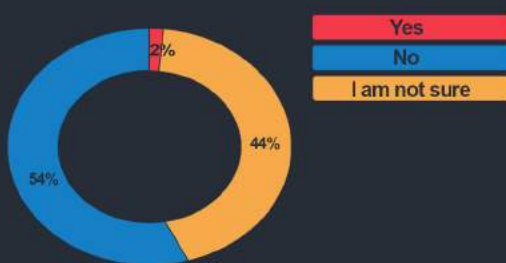

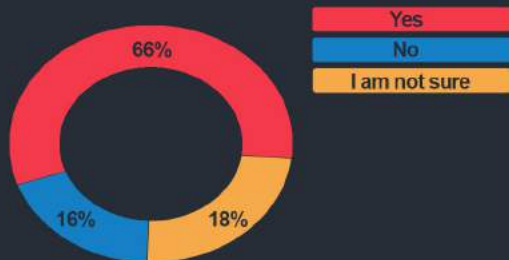

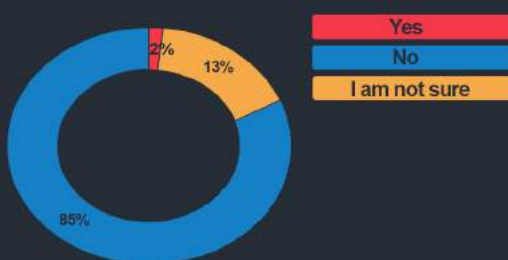

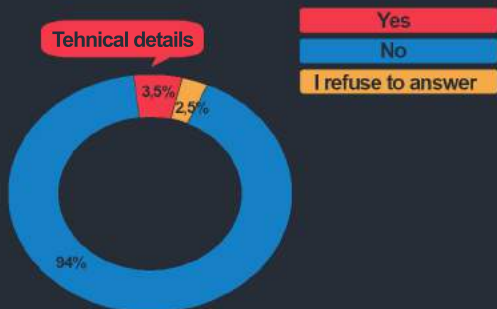

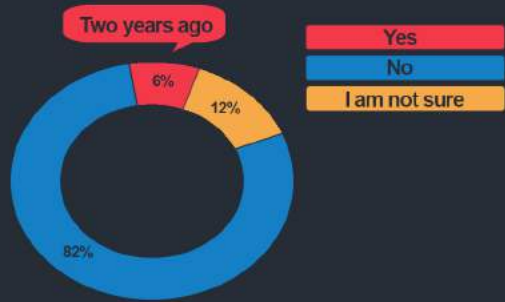

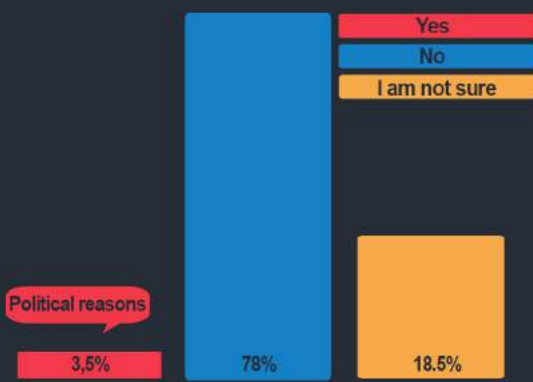

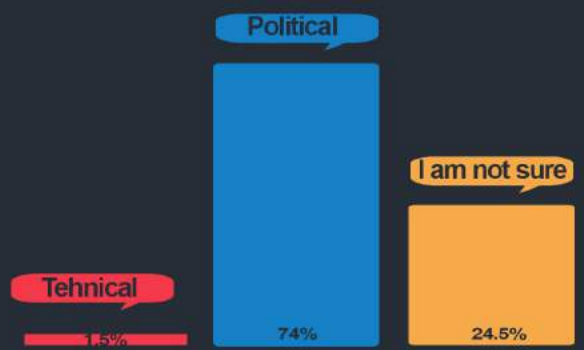

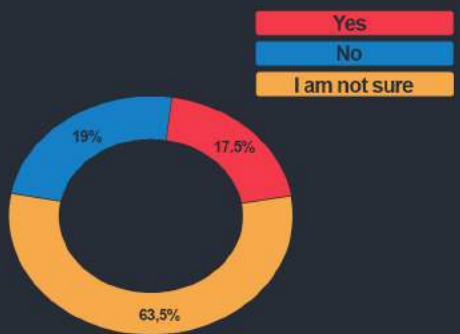

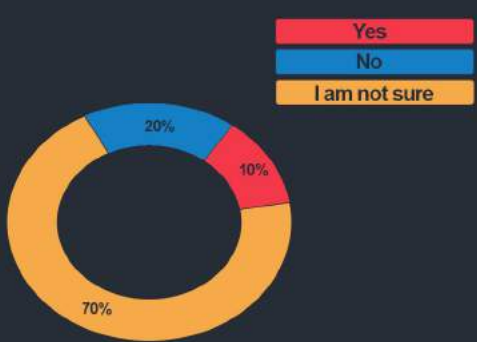

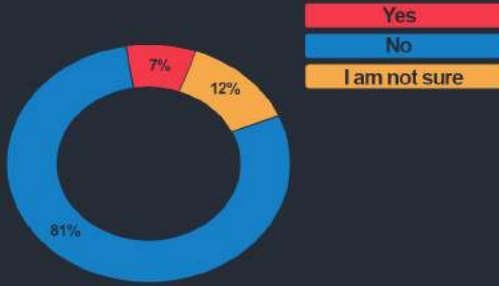

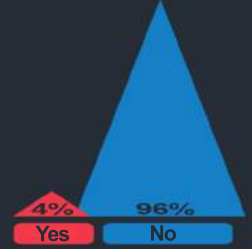

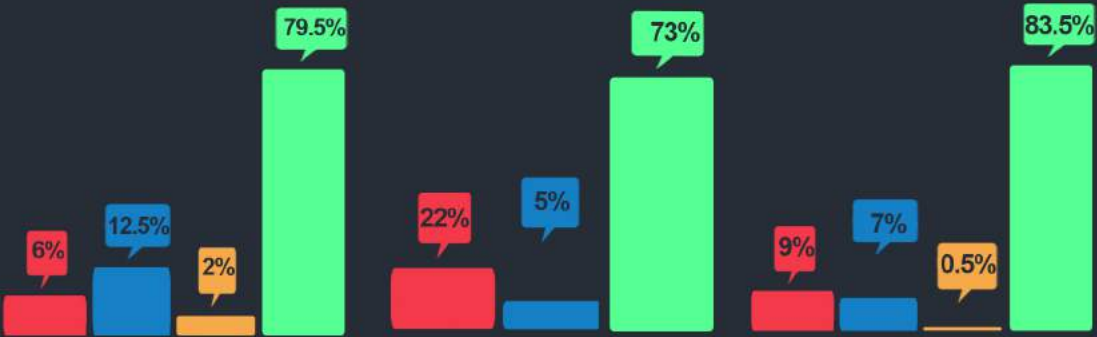

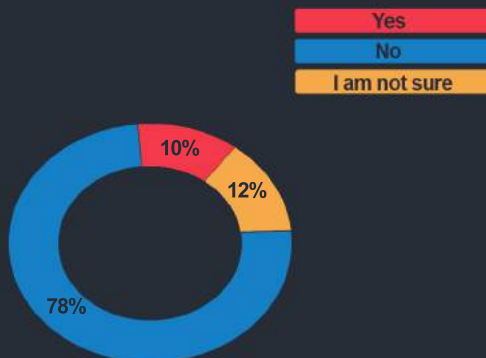

Aim of the project is to monitor implementation of the Agreement on the Judiciary and work of the newly established court in Mitrovica through enhanced participation of citizens, CSO activists and Law students. Within the project qualitative descriptive research was conducted. Aim of the research was to examine level and quality of information of citizens in the north regarding the Agreement on Judiciary made within negotiation process between Belgrade and Prishtina, so called Brussels Negotiations. Results obtained will be used to define approaches in organizing public debates and round tables with which ACDC aims to ensure better informing of citizens, as well as to increase transparency of entire process of implementation of Agreement on Judiciary.
