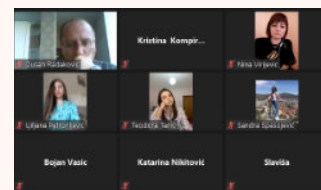
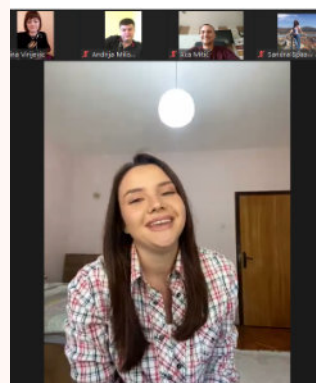
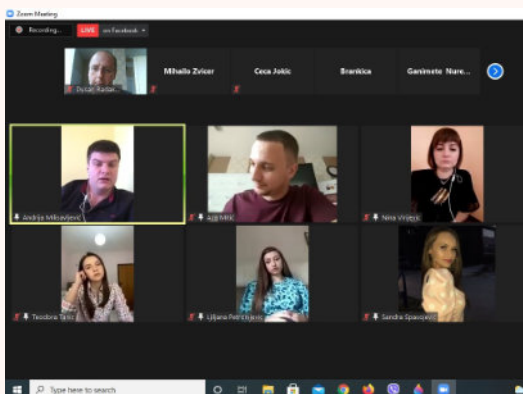

CONFERENCE "PROPERTY RIGHTS IN KOSOVO"

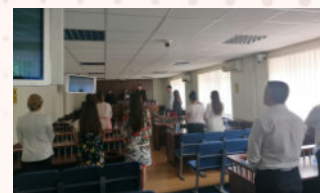

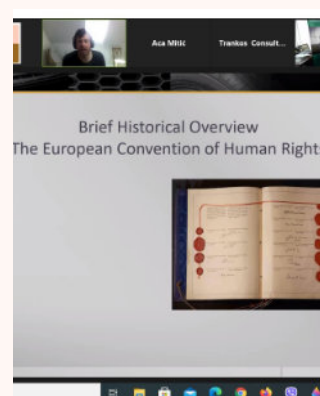
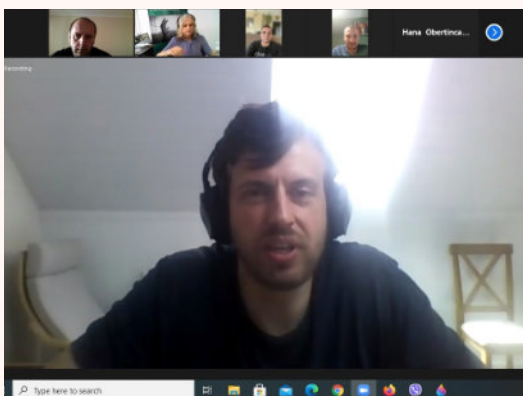
MOOT COURT TRIAL

The simulation was held on the case of attempted murder, which they easily solved using all available legal resources. Their resourcefulness in the roles of judges, court panel, lawyers, witnesses are assessed as impeccable. The trial simulation was prepared with the help of judges from the Basic Court in Mitrovica.
