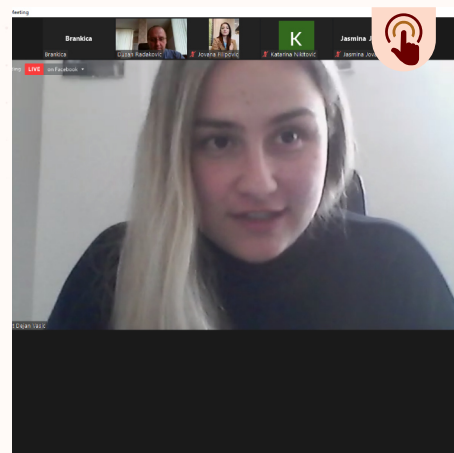
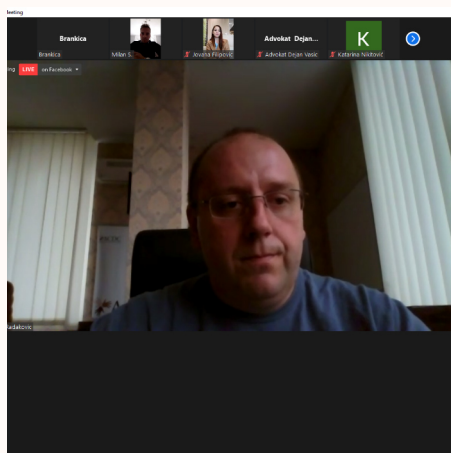




## CONFERENCE "YOUNG LAWYERS FROM KOSOVO AND SERBIA"

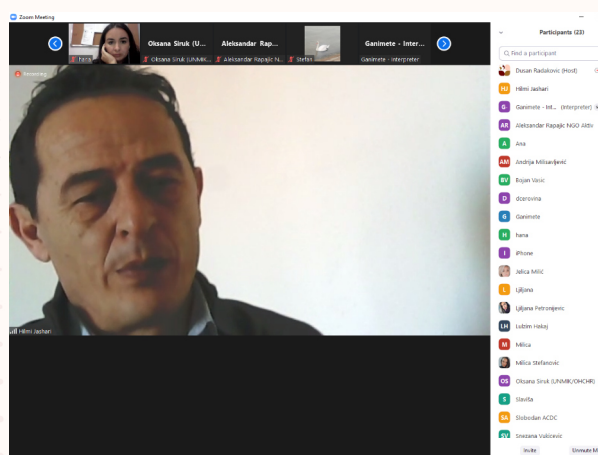
ACDC was represented by Dušan Radaković, who was one of the panelists of this Forum and presented the role of civil society in the defense and respect for human rights.

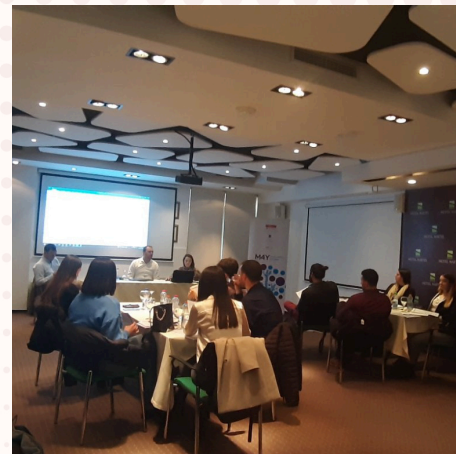

M4Y is a grant from the Japan Social Development Fund (JSDF) administered by the World Bank.

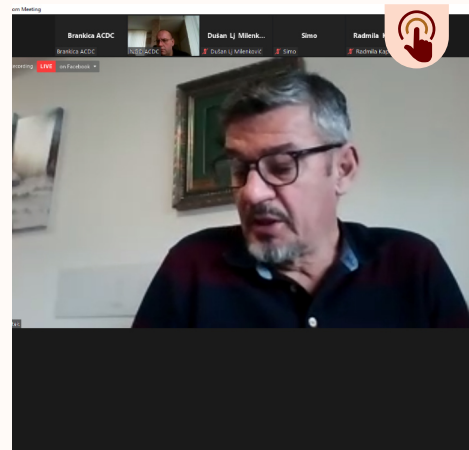
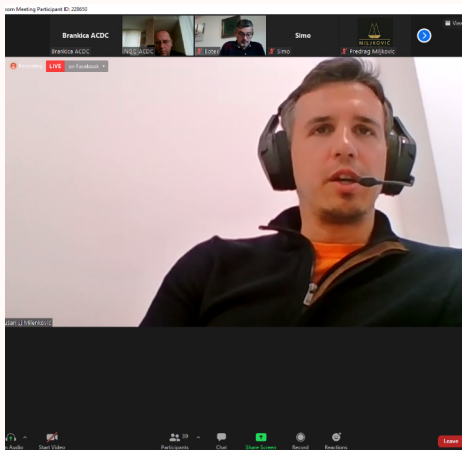

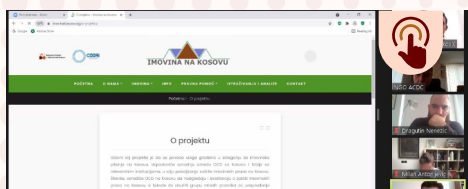

## FINAL CONFERENCE "PROPERTY ISSUES IN KOSOVO"

On the last day of November, a final conference within the project „Strengthening the protection of property rights in Kosovo“ was held. The main aim of the conference was to raise public awareness on the property issues in Kosovo and create synergy among different institutions, organizations, and experts to deal with these issues. Panelists at the conference were Marija Mišković, Agency for Free Legal Aid, Duško Čelić, university professor of law and legal experts Dragutin Nenezić and Milan Antonijević. The results of the research, conducted by ACDC and partner organization Center for Social Dialogue and Regional Initiatives (CSDRI) about property issues encountered by citizens, were presented.

At the conference, the website [www.imovinakosovo.org](http://www.imovinakosovo.org), developed by ACDC, was introduced. It has been launched to help anyone who has problems exercising their property rights in Kosovo. The website contains information on available legal mechanisms for the resolution of property disputes and information on available Free Legal Aid programs.

In November 2021, within the project "Enhancing Institutional Response to Corruption in northern Kosovo", ACDC started with activities that aimed to strengthen institutional awareness and knowledge on corruption and promote and encourage activities in preventing and combating it. Three focus groups on the topic of corruption in the north of Kosovo were held during this month. Also, an online survey was published in Serbian and Albanian language, aimed to find out the views and perceptions of citizens on the presence of corruption in the north. The research analysis will be presented in December.
