RESEARCH ANALYSIS - CITIZENS' ATTITUDES ON THE EFFICIENCY OF THE **JUDICIAL SYSTEM IN NORTHERN** KOSOVO

As part of the project "Enhancing Transparency and Rule of Law in Serbmajority Municipalities", the Advocacy Center for Democratic Culture (ACDC) conducted research that aimed to assess citizens' perceptions of the work and functioning of judicial institutions in the north of Kosovo.

MEETING INTERNS WITH THE DEPUTY PRESIDENT OF THE BASIC **COURT IN MITROVICA**

On 13.04.2022, in the Basic Court in Mitrovica, 10 chosen interns had a meeting with the Deputy President, Bekim Veliqi, before the start of the internship.

The Deputy President, Veliqi, welcomed the interns and explained what they can expect in the next three months during the internship, and what their roles and tasks in the court will be.

The interns are engaged through the ACDC on the project "Enhancing Transparency and Kule Serb-maiority in Municipalities" funded by INL in cooperation with the NGO ÁKTIV.

MOBILE LEGAL CLINIC IN **LEPOSAVIC**

As part of the project "Initiative for Education against Domestic and Sexual Violence", NGO ACDC organised activity an Leposavic with the aim to raise awareness problems of gender-based and domestic violence, as well as to the necessary information on the use of free legal aid for victims of violence.

3RD TOWN HALL MEETING

The third public town-hall meeting was held on April 19th and included prominent members of the media (Tatjana Lazarević – Editor of KoSSev portal, Nenad Radosavljevic – Director of RTV MIR and Darko Dimitrijević – Editor in chief of Radio Goraždevac) who gave their insight into the situation in northern Kosovo regarding corruption.



Media reporting on corruption, citizens' engagement and problems with reporting were also discussed during the meeting.

BROCHURE - THE KOSOVO ANTI-CORRUPTION AGENCY



As part of the project "Enhancing Institutional Response to Corruption in northern Kosovo" aimed at reducing corruption in northern Kosovo, the NGO ACDC launched a public campaign designed to raise public awareness and knowledge about corruption and anti-corruption mechanisms.

Within the campaign, an information brochures on the work of the Anti-Corruption Agency were published in <u>Serbian</u>, <u>Albanian</u> and <u>English</u> language.


WITH 10 TRANSLATORS AND 5 LEGAL ASSOCIATES

In the presence of The Deputy President of the Basic Court in Mitrovica, Bekim Veliqi, and UNMIK representatives, the executive director of the NGO ACDC Dušan Radaković signed a contract extension with ten translators and five legal associates at the Basic Court of Mitrovica for the period of three months.



Translators and legal associates are engaged through the NGO ACDC on the UNMIK-funded project "Facilitating Access to Justice and Promoting Human Rights in the Mitrovicë/Mitrovica Region".













PUBLIC LECTURES ON THE WORK OF OIK

In April 2022, NGO ACDC organized a series of public lectures entitled "The role and the responsibilities of the Ombudsperson Institution of Kosovo". Public lectures were held in Zvecan, Srbica, North Mitrovica and Skenderaj.





The events brought together students and young people who got the opportunity to learn more about the Ombudsperson Institution of Kosovo. Additionally, information brochures and flyers providing information on the work and contact details of relevant local offices in the Mitrovica region were distributed to the attendees.

The lectures are part of a public campaign realized as part of the UNMIK-funded project and aim to increase the visibility of the Ombudsman Institution in Kosovo.













M4Y TRAINING

As part of the project Municipalities for Youth, a series of training were held in April. The training aimed to provide young people with appropriate soft skills and project management entrepreneurial adapted to the subgrants budget and scope.

Young people who have completed the training will have the opportunity to apply for grants within their municipalities.







The importance of the missing persons in Kosovo is once again emphasized in the second media talk, where the guests were Mavrić, coordinator of the Negovan Association of Missing Persons from Velika Hoča and a representative of the Resource Center, and Ines Aljović Mihajlović, project coordinator.

During the discussion, Mr. Mavrić pointed out that the engagement of Washington and Brussels is necessary to resolve the issue of the missing persons.

The data was collected through focus groups and questionnaires conducted in three multiethnic settlements in northern Mitrovica and included people from all communities.
