# LOCAL INITIATIVES IN MULTI-ETHNIC DISTRICTS OF MITROVICA

Within the project "Promoting Inter-Ethnic Dialogue in Local Government", funded by the National Endowment for Democracy, three small projects in multi-ethnic districts of Mitrovica were supported.

Local project initiatives that address the needs of local communities have been developed and initiated by the communities with the support of Community Committees and local representatives.



Sports playgrounds used by young women from all communities have been renovated in the Bosnjacka neighborhood.



A children's playground was constructed within a building used by socially disadvantaged families in Mikronaselje.

The work of the cultural center in Brdjani was supported by the procurement of the necessary equipment.



NGO ACDC supported initiatives in all three multi-ethnic settlements in North Mitrovica in order to establish a friendly and sustainable environment for different communities. Projects will benefit all groups, with a special emphasis on culture, youth, and children. These small initiatives demonstrate to local communities that with their participation we can improve the living conditions of all communities.

The overall objective of the project "Promoting Inter-Ethnic Dialogue in Local Government" is to facilitate inter-ethnic cooperation among communities in North Mitrovica municipality.

## **HUMAN RIGHTS DAY**





The activity was carried out within the UNMIK-funded project "Further Support to Access to Justice and Human Rights in the Mitrovica Region".

# STATEMENTS ON INTERNATIONAL DAYS

In a statement released on December 1, the NGO ACDC called for non-discrimination against HIV-positive persons.

On International Day of Persons with Disabilities, we stressed the importance of respect for human rights and the equal participation of people with disabilities in the management of the society in which they live.

In honor of the International Day Against Corruption, we have encouraged citizens to testify against corruption.

On the Human Right Day observed on December 10, ACDC issued a statement and emphasized the importance of respecting the Declaration's guiding principles.

Shortly after the end of the 16 Days of Activism campaign on December 11, we reminded that prevention is the most effective way to stop gender-based violence.

# **PRESS RELEASES**

Tensions in the north of Kosovo culminated in early December when Kosovo Serbs set up barricades in northern Kosovo in protest of the arrest of Dejan Pantic, a former member of the Kosovo police. On this occasion, NGO ACDC, together with other organizations, published a press release calling on the international community and relevant institutions to react in order to protect the rights of Mr. Pantic to communicate with his lawyers and family.



In addition, we issued a statement condemning the ban on the Serbian Patriarch's entry into Kosovo and urged Pristina authorities to apologize to the patriarch, stating that the current crisis in Kosovo must not be used as an excuse to violate the law and the constitution.



A diverse group of civil society organizations from Kosovo and Serbia, including NGO ACDC, have adopted the joint statement calling for new constructive voices – voices that look to the future.



The coalition of non-governmental organizations for election observation "Democracy in Action" (DiA) issued a press release stating that insistence on holding elections in the four northern municipalities of Kosovo was tactless in the current circumstances.
