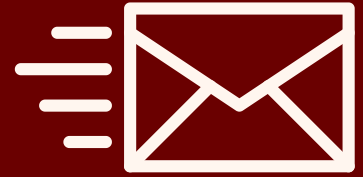

ACDC is entrusted with the administration of the grants in these municipalities.

In a recent meeting between the Mayor of Ranilug, Katarina Ristić Ilić, and members of the NGO ACDC, Dušan Radaković, and Aleksandar Rapajić, discussions focused on projects supporting the youth through the Municipalities for Youth (M4Y) initiative.

The project "Municipalities for Youth (M4Y)" is designed to empower young people to fully participate in the planning and implementation of local socio-economic activities.

This initiative was not only aimed at cleaning the riverbanks but also at raising public awareness about the importance of safeguarding rivers as essential water resources and public spaces.

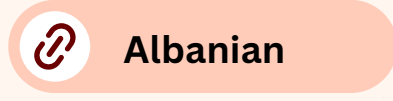
## Info session - Kosovo Specialist Chambers

In this capacity, NGO ACDC invites all individuals facing difficulties in exercising their rights in Kosovo to visit the office and connect with legal associates who will offer free legal services, information, and advice.

The recent visit from the SMART Balkans team to NGO ACDC was focused on assessing the progress of our initiatives, reviewing the attained results, and addressing the challenges encountered.



### New Project Announcement

We are excited to announce a new project funded by UNMIK focused on advancing human rights through increased public awareness. The project aims to strengthen the Forum of Cooperation between the Ombudsperson Institution of Kosovo (OiK) and Civil Society. It also aims to develop online complaint forms on the OiK's website, and enhance awareness of human rights and redress mechanisms. Furthermore, the purpose of the project is to increase awareness of the residents of northern municipalities on their rights and fundamental freedoms.

### Flood Prevention Campaign and Local Plan Development

As part of the flood prevention campaign carried out by ACDC, a Local Plan for the Municipality of North Mitrovica, aimed at reducing the risk of floods and ensuring an appropriate response in emergency situations, has been developed. This plan is available on our website in all three languages.



### Skills Development Opportunities for Youth

As part of a project funded by GIZ, a call was made for participation in workshops and training sessions, offering young individuals a unique opportunity to enhance their skill set and acquire valuable knowledge in different fields. These training sessions are scheduled to commence in November.
